We received our seventh landlord report from the Scottish Housing Regulator and in this report we want to share our results. We will show you how we performed, compare our results against the Scottish Average as reported by the Regulator and, on occasions our "peer group", which consists of 38 registered social landlords that are of similar size and operate in an urban setting. On reading this report you will see how we compare across a range of categories. Overall, we believe we compare favourably against the Scottish average and our peers across the majority of measured indicators. However, we will continue to make every effort to keep improving our services.
